An interim staff member will be needed for the Little Lambs Ministry. Steve Moberg (member of Coordinating team/HR) and Dave Wiersma will determine the compensation level for the Interim Childrens Ministry Director position.

- Audit Team Request: The audit team has discovered an accounting and processing discrepancy with bonuses paid to pastors. Audit team is advised to note this issue in the audit and make recommendations.
